

NOTICE OF A RATE HEARING

Enova Power Corp. has applied to increase its electricity distribution rates effective January 1, 2026

Enova Power Corp. (Enova Power) has applied to the Ontario Energy Board (OEB) to increase its electricity distribution rates in the Kitchener-Wilmot Rate Zone (KWRZ) and the Waterloo North Rate Zone (WNRZ) effective January 1, 2026.

The requested rate changes are set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Enova Power would see the following increase:

Customer Class	KWRZ	WNRZ
Residential (750 kWh)	\$0.90 per month	\$1.28 per month
General Service less than 50kW (2,000 kWh)	\$2.10 per month	\$2.20 per month

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

Enova Power has also requested approval:

- Dispose of the balances in certain deferral and variance accounts including accounts that are collectively referred to as Group 1 accounts for both rate zones
- Finalize interim standby rates in the KWRZ

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

IMPORTANT DATES

You must engage with the OEB on or before **September 16, 2025** to:

- Provide input on the hearing type (oral, electronic or written)
- Apply to be an intervenor

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
